Simple Way to Become Informed on Islam

An innovative approach that counters the politically correct media portrayal of Islam. As a secular scientist (Kafir), Bill Warner has applied an objective, fact-based analysis to Islamic texts.

The beauty of this study lies in not having to consult any Muslim third party and navigate the sacred deception of taqiyya. The 'Trilogy' (Quran, Biography, and Ahadith) alone are sufficient.

As following Muhammad in the smallest detail is required to be a good Muslim, any 'Quran-only' apologist is exposed as deceitful or ignorant-the Quran just doesn't have enough detail to practice the religion.

Islam as a political ideology is proven by murder of those rejecting Muhammad as a prophet; an attack on Muhammad is taken as an attack on Allah. It is a uniquely Satanic system as no one today engages in mass murder in the name of any dead general or dictator.

As a comparison, true Christianity is not a political system as no Christian advocates killing people who insult Jesus (which is done daily):

"Verily I say unto you, All sins shall be forgiven unto the sons of men, and blasphemies wherewith soever they shall blaspheme:"

Mark 3.38, Authorized Version

Islam is dualistic in nature which is why ignorant Kafirs and Dhimmis are so easily deceived, e.g.: two Muhammad's (one religious-in Mecca, one political-in Medina); two jihads (personal struggle/the sword), two doctrines on women (honour and protect/beat them lightly). After a jihad strike apologists can simply point to the Meccan Quran and lie saying Islam is peace.

Warner: "Islam as a religion was a failure, only when he turned to jihad and politics did Muhammad have success."

The great historical lies of Islam are revealed: the 'Golden Age' in Al-Andalus, Muslim African slave trade, and the Crusades a response to 450 years of the Middle East being put to the sword.

This short book will do exactly as prescribed-self educate a Dhimmi. It should be required reading especially for Christians being pulled into 'Chrislam' heresy and ecumenism.

Introduction (pp. 1-7)

The Quran is insufficient alone to practice Islam-it refers believers to follow him in 91 verses so without further instructions a Muslim cannot be a true Muslim.

Directions come from the Sirat (biography) which constitutes 26% of Islamic literature, and Hadith; predominately Bukhari (60%). The Quran is only 14%.

This is Islam's 'Trilogy of Books'.

Perhaps the most important topic in the Trilogy are Kafirs; 60% is on this topic (Sira is 81%). This point is crucial as it means

60% of Islam is political in nature-impacting those who want nothing to do with Islam's religious doctrine.

A Kafir is not merely an unbeliever, but a derogatory term covering anyone who does not accept Muhammad as the final prophet (including 'People of the Book'). An early Quranic verse in Sura 5 pays Jews and Christians some respect, but a later one (9.29) orders their destruction.

Before taking up the sword Muhammad, in thirteen years (610-622) converted 150 people, then in the next ten (623-632 [death]) he became a king of Arabia.

There are three views to apply on historic events of Islam (e.g. Muhammad's beheading of the Quraish Jewish men who refused his prophet hood):

- (i) Islamic
- (ii) 'liberal'
- (iii) apologetic

Muhammad (pp. 8-13)

Contrary to popular opinion, a Muslim is not one who simply worships Allah, only who worships exactly as Muhammad did (the 'Sunna'). This means forbidding what Muhammad did, and permitting what he permitted. As an example, most Muslims are quickly angered as from the Hadith Muhammad was quickly angered.

Muhammad is taken as the perfect father, husband, political, religious and military leader.

In Mecca he caused trouble with his aggressive approach for thirteen years, but was under protection of his powerful uncle. With his death, the Meccans told Muhammad to leave so he fled to Medina. Medina was one-third Jewish but soon they were all driven out.

While Mao directly killed the most people (40M) in history, Muhammad (through the politics of jihad), has been responsible for 270M.

Muhammad also never forgot an insult and had to avenge it, which explains why any perceived insult against him is a death sentence in Islamic countries.

Before Muhammad, Arabs were well known for their religious tolerance.

The most common name in the world is Muhammad.

Muhammad's dying words were "let their be neither Jew nor Christian left in Arabia".

The West has been intentionally betrayed by those in power who have refused to educate people on the reality of political Islam. The Islamic 'Golden Age' meme has been substituted for the mass-murder of 270M Christians, Hindus, Buddhists and North Africans, the annihilation of cultures and civilisation.

This study is enlightening to say the least, providing evidence to counter the leftist drivel of the 'religion of peace'.

<u>The Basics</u> (pp. 14-18)

Five pillars:

^{*}Shahada.

^{*}Zakat: Payable to Muslims only (not Kafirs). Can also be funnelled for Jihad.

^{*}Five daily prayers.

^{*}Ramadan (no food or drink in daylight hours).

*Once-in-a-lifetime Hajj to Mecca.

Jihad is a Sixth Pillar.

64% of the Quran is devoted to Kafirs.

There is no Golden Rule in Islam.

Islam is self-contained, having no use for any other civilisation. Once implemented, only force from outside is capable of dislodging it. It was only ever stopped in 1492, Spain, and 1683 in Eastern Europe.

The 1,400-year death toll is 270M: 60M Christians, 80M Hindus, 10M Buddhists and 120M North Africans.

Jihad (pp. 19-24)

All Jihad is defensive as refusing to acknowledge Muhammad is an insult, or offence to Muslims and warrants action.

It can be carried out with sword, mouth, pen and money.

31% of the Trilogy is devoted to Jihad and 98% of the Hadith when it mentions the Kafir is about killing them.

Theft achieves a dual purpose-wealth removal to weaken the target, and wealth gain to support more Jihad. WTC attacks were designed to paralyse the U.S. economy.

Education Jihad; no textbook can be issued without Islamic approval.

Financial Jihad is primarily provided by Saudi Arabia, which sends three times as much as the Soviet Union did on spreading Communism. Most mosques are built with Saudi money then staffed with an Imam of choice.

Jihad killings are justified in that offences from Kafir's are more serious to Muslims in their eyes than their death. Muslim revenge on the Meccans is an example-although Muhammad was expelled he (obviously) wasn't killed, but for that offence the Meccans were justifiably killed.

Muslims must be perceived as victims if any Jihad occurs which is the religious cloak.

Islamic Time begins with Muhammad's move into political Jihad in Medina which catapulted the growth of Islam.

Jews (pp. 25-30)

Islam wouldn't exist without Jews as Muhammad claimed a vision from Gabriel, an angel in Judaism.

The main doctrine towards Jews is hatred:

- *A former Turkish Prime Minister: "The Jews are bacteria and like a disease"
- *American Centre for Islamic Research: "Jews murder non-Jews and use their blood for Passover matzos."
- *Egyptian Islamic Researcher: "The Jews are among the most vile creatures of Allah."
- *Egyptian Cleric: "Hitler was right to do what he did to the Jews."
- *Ibn Hazm, Medieval Spain: "They are the filthiest and vilest people..."

*In Iran, c16thC Jews were drawn for surrounding areas on Friday evening and after torture 350 were forced to convert to Islam.

Muhammad destroyed three Jewish tribes living in Medina, about half the population. They denied his prophet hood which angered him, and is reflected in the Medina Koran's anti-Jew content, as opposed to the Meccan one.

From weakest to strongest he attacked each tribe-who would not help each other due to differences. All males from the third tribe were beheaded in the marketplace a day and into the night in Medina, with twelve year old Aisha standing by.

Muhammad then went north to attack the Jews at Khaybar. These simply surrendered and accepted terms; thus the Dhimmi was born. These had to pay *jizya* (up to 50% of their wealth) and were permitted only to be Jews in their Synagogues and homes.

Three years after, Caliph Umar drove every Jew out of Arabia.

The dualism of Islam expressed in: 'they are apes and rats' or 'we are brothers in religion'.

No one wants to remember their people's dreadful history of dhimmitude, so the lie of the Islamic Golden Age was invented, especially in Al-Andalus. Although a minority of Jews and Christians in high office prospered, the Spanish warred for seven hundred years to expel the Golden Civilisation. In one day the Muslims killed 4,000 Jews in Granada.

Christians (31-36)

There is also duality with Christianity-Islam first deceives then destroys it. In Muhammad's last days he sent troops to attack

Christians in Syria. The Middle East, North Africa and Turkey were all Christian prior to Islam.

After 9/11, some imams were invited to a church in the US to talk:

- *Muslims and Christians worship the same god.
- *Jesus is not the Son of God, but a Muslim prophet. All the Apostles were Muslims.
- *Jesus was not crucified, and therefore not resurrected.
- *The NT is corrupt and to learn about the real Jesus the Quran is required.

The Christians were all ignorant of this, also did not know what happened to the seven Churches in Asia, the last of which, Smyrna, was destroyed in 1922. They were also ignorant of the fact every black slave sold to a white man in Africa was sold by a Muslim wholesaler, and the Arabic word for black slave is abd.

The Crusades were said to be a response to Christian's cry for help

Dhimmitude (pp. 37-41)

Those who fail to study Political Islam will lose their civilisations. Dhimmitude is a tool to destroy the conquered culture, e.g.:

- *Hindus in Pakistan.
- *Buddhism in Afghanistan.

- *Copts were forbidden to speak Coptic before Muslim masters. The Egyptian Pharaonic/Greek culture was destroyed with the arrival of Islam.
- *Defacement of indigenous structures (e.g. Sphinx's nose).
- *Conversion of valuable/important buildings into mosques, removal of marble pyramid veneer.
- *Destruction of Churches (20,000 in Greek Anatolia-Smyrna was destroyed only in 1922).
- *Forbidding of ringing Church bells as Muhammad thought they were Satanic.

Dhimmis are slaves-modern politicians and apologists. The psychology of dhimmitude is that of a bullied victory-one who hopelessly seeks to placate an ever-voracious persecutor.

Modern examples of Dhimmitude:

- *Forbidding the naming of Islam as the enemy (the war on 'terror', which is an effect, not an entity).
- *US airports fitting plumbing for Muslim foot washing.
- *University 'meditation rooms' monopolised by Muslims.
- *Allowance of foreign polygamous wives into UK, and payment of welfare benefits.
- *Not printing cartoons, articles, etc. for fear of persecution.

What were the Dhimmi's to be protected from?

No Islamic country is strong enough currently to enforce dhimmitude, so there are often riots and extra-legal persecutions and bigotry.

Women (pp. 42-48)

Again, Islamic dualism is on display-women can be both honoured and protected, and beaten (if she disobeys her husband). Women are not equal to men on earth, as their legal testimony is only half that of a man.

On Judgement Day they are equal, but the judgement criteria will be obedience to their husbands. Also, rewards of fleshly pleasures for men are absent for women. In Islam if a woman, dog, or donkey walk in front of you while praying the prayer is negated.

On the Afghan/Pakistan border, U.S. soldiers photographed every face for recognition and nine of ten women had facial bruising. In a Pakistan survey, 90% of women had been beaten, and in Chad anti-wife beating laws were protested as being against Sharia.

Muhammad said women should be beaten lightly.

On marriage, in 2002, Afghanistan/Pakistan half the girls were married by thirteen and one sixty year old man was engaged to a ten-year old girl.

An honour killing is when a man kills a woman because she has violated his honour. At Badr, a son realises it was best he had killed his father seeing as he was a Kafir.

On veils, Muhammad made all his women wear them, and in 2002, Saudi Arabian Police stopped a rescue on a girls school because their faces weren't covered.

On stoning the stone size must be small so they don't kill immediately.

Not a single Women's Study department teaches about the Sharia for women.

Slavery (pp. 49-54)

Muhammad was a slave owner and trader.

A contemporary account of slavery is with Francis Bok, captured with his sister in Africa while going to market to sell beans. His sister was raped every night and he ended up living in a barn with the animals.

Francis' captors called him Abd although in Arabic there are forty words for slave (a e.g. a mamluk is a white slave).

He tried escape but was captured and beaten. There are also Arabic words for escaped slaves (children and females included).

Muslims took many slaves from Eastern Europe, which is why that people group are called Slavs. Blacks were put to hard physical work but white slaves in administration (they could even enter the army). The most valuable was always a white woman.

Muhammad's favourite slave was a white Copt Miriam. He had slave tailors, cooks, doctors, etc.

Black slave eunuchs were totally emasculated.

Over two hundred years, whites bought 11M slaves from Muslim slave traders, but Muslims sold 14M into North Africa and Asia. The collateral damage for one slave was on average

between five and ten persons, so 25M black slaves meant ~120M murders.

In Africa David Livingstone noted a medical disease where black slaves with plenty of food simply died from a broken heart.

Slavery is Islam's darkest secret.

Ethics (pp. 55-60)

Islam practices sacred deceit, called *taqiyya*. This is derived from Muhammad who permitted his follower to lie avenge him of a jew in Medina, al-Ashraf who had condemned him.

In Beslan, Russia, 2004 Muslims took school children hostage for days. Some were shot in the back jumping through windows, then the roof was brought down by explosives.

Jihad ethics are always confusing to the Kafir; there is no Golden Rule due to the strict division between Kafir and Muslim. The Rule does exist in the Meccan Quran, but is abrogated in the Medinan one.

Suicide is forbidden, however under the doctrine of dualism, killing yourself while trying to kill Kafirs guarantees paradise. The word 'martyr' has the opposite meaning in Islam.

From hadith, the way of Muhammad is to torture the Kafir.

The strange political creature if the dhimmi is just that.

Kafir Treaties can be abrogated as long as it is favourable to Islam.

Quran (pp. 61-66)

The Quran is believed to have been created before the universe and sits on an emerald table at the right hand of Allah.

It was written in classical Arabic (meaning god is an Arab) which most modern Arabs cannot even read.

Since Islam is submission, the corruption of the NT and OT must be believed by divine fiat.

It is a repetitious, tiring and disjointed book. Eliminating repetition reduces it to \sim 50% of its size.

Critically, contradictions can only be resolved by understanding which verse was revealed the latest. The Meccan Quran is more religious, centered on hell and the Kafir who rejects Muhammad as Allah's prophet. The Medinan Quran however is very political.

Where OT violence is time-bound and culturally restricted, Quranic violence is eternal and universal. This is a counter to the popular dhimmi apologetic.

The Quran boils down to to simple ideas-Muhammad is the final prophet and Jihad may be used against Kafirs.

It is Muhammad's life that gives meaning to the Quran, why the hadith and sira are so important.

Submission and Duality (pp. 67-71)

Allah, Muhammad, Kafir, Dhimmi, Slave is the submission-chain of Islam.

No textbook can contain anything critical of Islam, reflecting dhimmitude of Western governments.

The Meccan Quran is a shield or teflon coat used when terrorism occurs. The reason there are no counter-jihad Islamic protests after events is the Medinan Quran has primacy.

Dualism allows a Muslim to have a compartmentalised mindkey to understanding their psychology.

Afghanistan used to be Buddhist, now there is not one left.

Islam works with a thousand year plan.

Tears of Jihad (pp. 72-78)

After Muhammad's death, Abu Bakr spent three years suppressing revolting Arabs.

The Middle East was basically Greek in culture, with continual warfare between them and the Zoroastrian Persians. A further difficulty was the enmity between Greek Orthodox and Roman Catholicism of Rome, Syria, Jerusalem and Egypt.

The result was an Islamic conquest of Syria, Iraq (635 and 642), Egypt and North Africa in only thirty years. Only Greek Anatolia remained. Native Copts became second class citizens in their own land, and European culture of North Africa was wiped out.

Christians called invaders Arabs and Saracens, never Muslim jihadists. Conquered Christian dhimmis were forbidden to read the Quran to ensure ignorance. They were also killed when news was received of losses at Constantinople.

Religious art was destroyed, e.g. Buddhist statues along the Silk Route had their eyes and mouths pecked out. Zoroastrian texts were purged. Buddhism in Afghanistan was destroyed.

India has reduced in size by half in three stages: 712AD at Debal, Karachi, 1000AD in Northern India, and in 1206AD.

Today in Afghanistan there is a mountain range Hindu Kush ('funeral pyre'). Pakistan was once part of India, but the British partitioned it off as an Islamic state with the death of about a million Hindus. This was facilitated by Ghandi, who said while all Hindus must leave Pakistan, Muslims in India could stay. In Bangladesh, Islamicisation still proceeds-as at 1947 it was about 90%.

The first 9/11 was in Vienna when the Turkish Muslims were defeated. Since the second 9/11, which was a type of revenge for the first, there have been $\sim 17,000$ Jihad attacks.

Conclusion (pp. 79-84)

In Islam there can never be freedom of expression as that would mean Islam could potentially be faulted. It is only useful for *taqiyya* purposes. The sharia forbids Press Freedom.

Islam has never acknowledged its part in the African slave trade.

In law, a Kafir cannot testify against a Muslim.

Islam has no human rights, as Kafirs are hated by Allah and subhuman.

The Left's pipe dream is to reform Islam, which is impossible as you cannot reform perfection without destroying it. Violent jihad is the cornerstone of Islam's success and it is working better now than ever before.

Another Leftist smokescreen is the 'good Muslim', the third type of Muslim (as opposed to the Meccan and Medinan). He is to some degree an apostate by following the Kafir Golden Rule.

Western ignorance of Islam is the cause of its weakness.
